Godiva Liqueur Original/Godiva Chocolate Liqueur - Godiva has discontinued the *pareve* Godiva Liqueur aka Godiva Liqueur Original. The new product, Godiva Chocolate Liqueur, bears an OU-D. The old product still in circulation remains *pareve*. Consumers are advised to check the label names very carefully. Godiva Caramel Liqueur, Mocha Liqueur and White Chocolate Liqueur are certified kosher and Dairy.

Trader Joe's Maple Pecan Clusters cereal bears a Half Moon K *Pareve* on the label and notes non-fat milk on the list of ingredients in error. The product does not contain non-fat milk and is in fact *Pareve*.

Chef's Quality Assorted Rolls (RCA-128RD) that are packed with Parmesan Rolls bear an unauthorized KVH symbol. The product is being removed from the shelves and new packaging will not have the KVH on the boxes.

Gabilas Knishes - The following products contain dairy ingredients and are to be considered Dairy per the ingredient panel. The Dairy designation was inadvertently omitted from the packaging, and corrective action has been taken. These products are Kof-K Kosher certified and Dairy:
